NOW, THEREFORE, If the Tax Administrator shall issue the certificate applied for, and if the  
principal shall pay all taxes, interest and penalties prescribed in accordance with the provisions of  
Chapter 30 of Title 44 of the 1956 General Laws as amended, then this obligation shall be void; other-  
wise it shall be and remain in full force and effect.

after the expiration of this bond as herein provided, unless a certificate be issued by the Tax Adminis-  
trator to the effect that all taxes due to the State have been paid.
